## **DCRM 2025**

The Dutch Society of Rehabilitation Physicians (VRA) is organizing the DCRM on November 6 and 7, 2025, at the Beatrix Theater in Utrecht.

Dutch healthcare is under pressure due to increasing demand, staff shortages, and long waiting times. These challenges are also felt in rehabilitation medicine. This calls for a critical look at the effectiveness and value of healthcare activities: just because something can be done, does it need to be done?

This year's DCRM conference is centered around the theme: "Less is more? Meaningful rehabilitation care for the patient." This theme is sometimes seen as a call for limitation, but in reality, it's about improvement. Less, but more targeted care not only means more efficient use of resources—it also leads to better care for the patient. No one benefits from unnecessary or meaningless treatment. Patients themselves want care that meets their needs and genuinely improves their quality of life. Together, we will explore how rehabilitation medicine can become even more purposeful and meaningful.

During the conference, we offer a wide range of workshops, poster sessions, and mini-symposia where we collaboratively examine how to further enhance rehabilitation care. There will also be an interactive debate session where we engage in dialogue about the future of meaningful rehabilitation. Inspiring keynote speakers will share their vision and challenge us to critically reflect on the way we work.

We warmly invite rehabilitation physicians, researchers, residents in rehabilitation medicine, medical specialists, and other healthcare professionals to submit abstracts for workshops, mini-symposia, posters, or oral presentations. In addition, we challenge everyone to take a critical look at their own daily work: which activities truly add value? What could be done differently?

We look forward to welcoming you in person at DCRM 2025 at the Beatrix Theater in Utrecht!

Accreditation will be applied for physicians in rehabilitation medicine and for physician assistants.


#### Participants & target audience







#### Article 1. General

- 1. Participation to DCRM congresses as exhibitor is only possible through written notification.
- 2. The DCRM can deny registrations without reason.

#### Article 3. Registration and payment

3. If the participating exhibitor does not meet the rent or any other costs, entirely and/or timely, the DCRM is entitled to declare the sponsor agreement as nullified. In this case the participant also forfeits any right to a refund of the fees or rents paid or on compensation for damages in any form or from any cause that was suffered. All costs of recovering failing payment, including both judicial and extrajudicial costs of a legal counsel of the DCRM and the costs incurred by the DCRM for recovery

1. In case of cancellation of an agreement, exhibitor is required to pay: - until 4 months before the Congress date 50% of the owed invoice amount; until 2 months before the Congress date 70% of the owed invoice amount; - until 6 weeks before the congress 70%, less than 6 weeks 100% of the owed invoice amount. If an exhibitor cancels participation, exhibitor is required to notify the DCRM in writing. The date of receipt serves as starting point

2. The DCRM reserves the right to make changes to the date and/or opening hours indicated in the notices, the supplementary information and sponsor agreement. In this case the sponsor agreement will remain in force. If the congresses cannot take place for any reason, the sponsor agreement will be considered as expired. 
